



user initials _____ **BagJump** is considered the most state of the art, action sports training device in the world. It is an enormous 50'x50' ft cushion for your landing rather than a snow surface. It is designed to eliminate the "trampoline effect" and impacts are absorbed with maximum softness. Freestyle skiers and snowboarders require appropriate speed, height and velocity. BagJump is designed to provide a training venue to progress your ability and skills.

user initials _____ **REQUIRED:** Each day your first BagJump **MUST** be a straight air.

user initials _____ Start on smaller features and work your way up. The BagJump is a Terrain Park Feature and should only be used by those that have progressed and are riding/skiing within their skill level. Develop your skills on Small, Medium and Large features before progressing to Extra Large features.

user initials _____ It is your duty/obligation to inspect and ensure your skis/snowboard are in proper working order, with **NO** broken or sharp edges.

ATML Model – Know the 4 Zones and have a plan before using any freestyle terrain

user initials _____ **APPROACH** zone is space for setting your speed and stance to use the feature. Approach the BagJump takeoff for your chosen maneuver as you would for any other similarly sized and shaped take-off.

user initials _____ **TAKE-OFF** zone is for making moves that start your maneuver.

user initials _____ **MANEUVER** zone is for controlling your body in the air and setting up for landing.

user initials _____ **LANDING** zone is center of the BagJump. On impact with landing zone, allow your momentum to carry you, rolling your body into the BagJump to allow maximum transfer of your landing energy as the BagJump deflates.

user initials _____ The BagJump Arena Requirements are listed below. No one is permitted into the enclosed training arena without the listed mandatory requirements. Entrance is only allowed while attendants are present. Any misuse of the BagJump will be cause for immediate resort dismissal, revoked privileges and will not gain access again.

Mandatory Requirements in order to access the BagJump Training Arena:

- Signed Liability Release. If a minor, an adult/parent/guardian over the age of 18 must authorize and sign liability release. A single liability release will remain on file at the **Vista Ridge Recreational Association and the Regional Municipality of Wood Buffalo** for the current winter season only.
- Mandatory Helmet Use. Any person entering into the **Vista Ridge** training venue must wear a helmet while using the Jump and BagJump.
- Must read and follow ATML Progression.
- Purchase a ticket from the **Vista Ridge** office to use the BagJump
- **Vista Ridge** hours of operation may vary due to wind/weather conditions
- The BagJump Arena will have an attendant at top and bottom of BagJump.

**RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT
(hereinafter referred to as the "Release Agreement")**

TO: Vista Ridge Recreational Association and the Regional Municipality of Wood Buffalo, (the "Releasers")

I and/or my child (collectively, "I", "me," or "my") have voluntarily chosen to use the Bagjump and all related activities (collectively, the "Bagjump"). I understand and agree that use of the Bagjump can be **HAZARDOUS**. In consideration for being permitted to use the Bagjump, I agree to **ASSUME ANY AND ALL RISKS OF INJURY OR DEATH** which might be associated with or result from using the Bagjump and any activities preparing to use the Bagjump (including training or other types of physical activity).

I understand that participation in the Bagjump involves many risks, including but not limited to, collisions with other participants and spectators, collisions with natural and man-made objects, configuration of the Bagjump, varying weather and visibility conditions, varying snow and terrain conditions, terrain park type features, performing maneuvers (inverted or otherwise), the acts of other participants, and all risks associated with participation in training, lessons, competitions and special events.

I understand that I will encounter various manmade and natural terrain features during my use of the Bagjump. I further understand that using the Bagjump may result in my body becoming inverted (either deliberately or involuntarily) and that inverted maneuvers may result in injury or death. I understand that I must inspect the elements, terrain, and Bagjump before I ski or ride over them to evaluate the risks and degree of difficulty before participating. I understand that the Bagjump cannot ensure my safety when performing maneuvers. I am solely responsible for knowing and understanding my ability to use the Bagjump. I understand that throughout the day snow conditions and terrain features will change.

HELMETS ARE REQUIRED. I understand that no helmet can protect me from all foreseeable impacts or injury. However, for maximum protection, the helmet must fit snugly and the retention system must be fastened securely at all times.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of The Releasees accepting my application for an access pass or card and permitting my use of the Bagjump, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against The Releasees, and its directors, officers, employees, instructors, guides, agents, representatives, volunteers, sponsors, independent contractors, subcontractors, successors and assigns (all of whom are hereinafter collectively referred to as THE RELEASEES), and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer resulting from either my use of or my presence on the premises or travel beyond the ski area boundary. DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE UNDER THE OCCUPIERS LIABILITY ACT, R.S.A. 2000, c. O-4, ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF THE ACTIVITIES REFERRED TO ABOVE

2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of or personal injury to any third party, resulting from my use of or presence on the premises;

3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity;

4. This Release Agreement and any rights, duties and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of Alberta and no other jurisdiction and;

5. Any litigation involving the parties to this Release Agreement shall be brought solely within the Province of Alberta and shall be within the exclusive jurisdiction of the Courts of the Province of Alberta.

6. In entering into this Release Agreement, I am not relying upon any oral or written representations or statements made by the Releasees with respect to the safety of the activities other than what is set forth in this Release Agreement.

I hereby authorize the use and reproduction of my image and/or likeness by Bagjump Arena and its authorized representatives, without compensation or restriction. Photographers executing this agreement understand that images they take of the Bagjump may be used by Bagjump Arena at any time, regardless of date used.

I HAVE READ AND UNDERSTAND THIS RELEASE AGREEMENT AND I AM AWARE THAT BY SIGNING THIS RELEASE AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.
